



ASQ-TRAK Practitioner Training Program

Important Information for Organisations

Ahead of booking an ASQ-TRAK Practitioner Training Workshop, as part of ASQ-TRAK Practitioner Training Program, it is important to read the following information. The program comprises:

- 2-day face-to-face workshop
- 1/2-day workplace practice task
- Optional activities (e.g. booster webinars)
- Ongoing access to resources



The workshops are delivered at your organisation for your staff exclusively, for a maximum of 14 people.

How much does ASQ-TRAK Training Program cost?

The overall cost of each Training Program consists of:

- 1. ASQ-TRAK Workshop Costs
- 2. Facilitators Travel Costs
- 3. Equipment Costs

1. ASQ-TRAK Workshop Costs

\$23,400+ GST. Trainer travel costs and equipment freight (where required) are additional.

2. Facilitators Travel Costs

Two accredited facilitators travel to a venue selected by your organisation to deliver training either on Country or in a centrally located space that best supports participant accessibility. Travel costs are determined based on the geographic remoteness of the selected venue (see Table 2) and cover flights, accommodation, car hire and meals for our Australia-wide facilitators.

To assess remoteness, we use the Australian Statistical Geography Standard (ASGS) Remoteness Structure (Edition 3, 2021). You can refer to the <u>Health Workforce Locator tool</u> to determine your location's classification. Please note that ASGS Remoteness Structure is due to be updated in July 2025.

3. Equipment Costs

Each ASQ-TRAK Practitioner Workshop requires five (5) ASQ-TRAK Tool Kits and five (5) ASQ-TRAK Toy Kits, (i.e. one kit and one toy kit for every 2-3 trainees).

These kits can be:

- Purchased directly by your organisation via the Royal Children's Hospital (RCH) Shop, or
- Hired from the STRONG kids, STRONG future team for the duration of the training, who will arrange
 delivery to and from the training venue.

When these materials are hired from our team, freight costs are applied (see Table 3).

These costs are based on the geographic remoteness of the venue, determined using the Australian Statistical Geography Standard (ASGS) Remoteness Structure (Edition 3, 2021). You can refer to the Health Workforce Locator tool to determine your location's classification. Please note that ASGS Remoteness Structure is due to be updated in July 2025.

Invoice Structure: STRONG kids, STRONG future issues payment requests for the full Training Program in two separate invoices:

- Invoice 1: Includes '1. ASQ-TRAK Workshop Costs' and '2. Facilitator Travel Costs'.
- Invoice 2: Includes '3. Equipment Costs'.

How is ASQ-TRAK Training Workshop delivered in the workplace?

Delivered by staff from the University of Melbourne's STRONG kids, STRONG future team, the workshop runs for 8 hours each day and covers:

- · Predicting and supporting healthy development in early childhood;
- The purpose and process of culturally appropriate developmental monitoring;
- The correct technique for administering, interpreting and communicating results of the ASQ-TRAK;
- Using the ASQ-TRAK to foster culturally safe developmental monitoring partnerships with families;
- Preparation for completion of a half-day of workplace practice with peer coaching (within six weeks of the workshop), to self-evaluate competency in using the ASQ-TRAK with fidelity.

The interactive format includes small and large group discussion, analysis of video examples, behaviour rehearsals, and hands-on time with the tool and materials.

Who can attend this training?

The training is suitable for anyone with an interest in implementing the ASQ-TRAK in their organisation. This includes practitioners who will be working directly with families, specialists who will be receiving referrals based on the screening outcomes, and managers who will be supporting the implementation at an organisational level.

How is the training recognised?

Participants who complete both the two-day workshop and half-day workplace practice task will be recognised as **Certified ASQ-TRAK Practitioners**. Participants who attend the workshop but do not complete the workplace practice task, will be recognised as an **ASQ-TRAK Supporter**.

What is included in the final price?

The ASQ-TRAK Workshop Costs (1) of \$23,400 + GST covers a 2-day face to face workshop and includes:

- Accredited ASQ-TRAK Facilitators
- All learning materials (workbooks, resources supporting interactive small group activities)
- Pre-training and post-training support
- Certification for 12 months
- Access to an online resource hub
- Access to Booster Webinars for 12 months
- Access to participate in a Community of Practice for 12 months.

Please note that Facilitator Travel (2) and Equipment Hire Costs (3) are additional to the ASQ-TRAK Workshop Costs (1).

Exclusions

The final training price does not include:

- Venue hire
- Catering
- Participant travel and accommodation
- Any costs associated with participants' completion of the workplace practice task.

What are some logistics about your organisation will need to consider prior to booking training?		
Venue	Room size – 16-person room PLUS breakout space. The same room should be available over two consecutive workshop days. The room should also be available for 2 hours before the day of the workshop for set-up.	
Audio-Visual Equipment	Projector or Smartboard with an HDMI connection is required.	
Catering	Host organisation covers the cost of the catering.

If you need to cancel your workshop booking, you must provide STRONG kids, STRONG future team with written notice, which will take effect when our team receives it. Any non-recoverable travel and courier costs will be excluded from any refund obligations.

The refund amount will be determined based on the following table:

2 week – 8 weeks <u>and</u> STRONG kids, STRONG future team <u>can</u> rebook the dates	Full Refund
2 weeks – 8 weeks <u>and</u> STRONG kids, STRONG future team <u>cannot</u> rebook the dates	50% Refund
2 weeks or less	No Refund

^{*} The 8-week notice period takes into account the planning for the logistics meeting, which is held at least 6 weeks before the workshop to ensure all arrangements are considered.

Cancelations by STRONG kids, STRONG future

We reserve the right to cancel the ASQ-TRAK Practitioner Training Workshop in the event of exceptional circumstances or unforeseen events beyond our control.
